## **Five Treatments for Historic Resources at NWC:**

(in Phase 1 and 2 areas as well as "The Triangle")

- 1. **Rehabilitation** incorporate rehabilitation of the structure into the site plan, if deemed feasible
- 2. **Relocation -** Document and identify the feasibility of relocation or reuse of the resource at a new location on the site
- 3. Salvage Document, reuse salvageable materials and demolish
- 4. Future Interpretation Document, interpret, and demolish the resource
- 5. Standard Demolition Document and demolish the resource



- Service Systems, Inc. (KM Concessions)/NWSS Coffee House 4699 Marion Street
- Denver Union Stock Yards (DUSY) Joint Track No. 2/Denver Rock
  Island Railroad parallel to Packing House Road
- DUSY Co. Joint Track No. 20/Denver Rock Island Railroad parallel to South Platte River




## The Pens 5000-5010 Packing House Road



- Built 1886
- Contributing to the Denver Union Stock Yards Historic District
- Inventory and develop a plan for both metal and wooden fences and gates that make up The Pens, including older pens found in Calf Alley. Determine which gates and fences are salvageable for reuse, and which will be made available to NWSS for fundraising or other campus place making efforts.

# Yards Features 5000-5010 Packing House Road

- Such objects include painted stall numbers; water pumps; concrete stem walls and concrete posts; metal gussets, hinges and latches; concrete and brick walkways; metal and concrete water troughs; loading docks and manhole covers. Such objects may prove useful for future artists and place makers on the new campus.
- Other campus artifacts are also being surveyed and saved for potential use in place making, including signs and posts; metal stairs and arrowhead cutouts; scales; tumbled pavers; utility poles and railroad-related hardware (if possible).



**4.** Future Interpretation - Document, interpret, and demolish the resource

- Packing House Road/National Western Drive (north of 46<sup>th</sup> Avenue to Race Court)
- Le Mouton 4877 Packing House Road
- Le Mouton/Bio Energy Building (double barrel roof warehouse) – 4875 Packing House Road
- Delgany Interceptor east Side of South Platte River




## General Strategy for Historic and Cultural Resources from Any Demolished Building

- Remaining Baldwin Court buildings under consideration for incorporation into the campus.
- Connect the history and legacy of both sides of Brighton Boulevard.
- The Campus Placemaking team will evaluate reuse possibilities as part of the future phases of redevelopment.
